## **Treasurer's Report – Addendum**

August 10, 2008

It was brought to my attention at Area Service on August 10<sup>th</sup> that an error had been made in the spreadsheet for July. The carried over amount for the Literature account came not from the previous month's balance, but from the subtotal of the previous month's account balance plus the moneys received from groups for literature purchases. This caused an error in the amount by nearly three thousand dollars.

In going back over my accounting spreadsheet, I found that the error occurred not just in July, but in June as well. This was unintentional, and the result of an erroneous pointer from one sheet to another. Consequently, from June to August the Literature account was showing about six thousand dollars more than was actually in the account. I apologize for this error, and have made every effort to find any other errors in the spreadsheet that I've been using. Luckily, there weren't any other errors, so the corrected spreadsheets should be accurate.

In order to disclose the actual amount, I'm sending to Diana the corrected accounting sheets as well as the corrected reports for June and July along with the August report and spreadsheet.

Hopefully this will answer any questions about what happened and how it was fixed, but if anyone has any further questions, please do not hesitate to contact me.
